

JIGGLEJIGGLE ACCEPTABLE USE POLICY

Introduction

This policy applies to your use of JiggleJiggle and forms part of <u>Our Agreement With You</u>. You must comply with it if you want to use JiggleJiggle.

It sets out the standards that apply to any and all content (including comments, posts, live streams, video or audio, hashtags, links or other material you upload or share on our platform or generate on our platform, including any contact you make with other users on our platform and all other ways you use our platform (**User Content**).

You must comply with these standards in spirit as well as to the letter.

We will determine, in our discretion, whether any User Content or your use of our platform breaches these acceptable use standards.

1. You may not use our platform:

- in any way that breaches any local, national or international law or regulation;
- in any way that is unlawful or fraudulent or has any unlawful or fraudulent purpose or effect;
- in way that involves hate offences, controlling or coercive behaviour, drugs or psychoactive substance offences, firearms or other weapons offences.
- in any way that involves human trafficking offences, sexual exploitation of adults offences or proceeds of crime offences;
- if you are a registered, or required to be a registered, sex offender or have been convicted of any serious crime;
- for the purpose of harming or attempting to harm any person in any way;
- to bully, insult, intimidate, harass, stalk, make threats to or humiliate any person;
- to send, knowingly receive, upload, download, share, post, use or re-use any material which does not comply with these content standards;
- to send a grossly offensive, indecent, obscene or menacing message intending to cause offence, menace, distress or anxiety;

- to extort money or other benefit from any personal in exchange for removal of User Content;
- to send unsolicited sexual content to another person;
- to deceive users about the nature of User Content;
- to pass off recorded User Content as a live stream;
- to impersonate another individual or entity;
- to harvest personal data (including financial data) from other users of the platform;
- to sell or purchase any used or soiled clothing items;
- to take any action that may impose an unreasonable large load on our systems or otherwise make excessive demands of it;
- to transmit, or procure the sending of, any unsolicited or unauthorised advertising or promotional material or any other form of similar solicitation (spam);
- to knowingly transmit any data, send or upload any material that contains viruses, Trojan horses, worms, time-bombs, keystroke loggers, spyware, adware or any other harmful programs or similar computer code designed to adversely affect the operation of any computer software or hardware.

2. User Content must:

- must be accurately described;
- avoid topics that may cause offence or otherwise be inflammatory to others, for example, geo-politics or culture as these will not represent the views of everyone on the platform or their audience; and
- comply with the law applicable in any country from which it is posted and to which JiggleJiggle targeted.

3. User Content must not:

- include anyone under the age of 18 or anyone over the age of 18 (or the age
 of majority in their country) unless they are a registered user of the platform;
- · be defamatory of any person;
- be offensive, hateful or inflammatory;
- infringe any copyright, database right or trade mark of any other person;
- be likely to deceive any person.

- breach any legal duty owed to a third party, such as a contractual duty or a duty of confidence;
- contain illegal content or promote any illegal content or activity;
- be in contempt of court;
- be threatening, abuse or invade another's privacy;
- be likely to harass, upset, embarrass, alarm or annoy any other person;
- impersonate any person or misrepresent your identity or affiliation with any person;
- give the impression that the User Content was produced by any other person;
- advocate, promote, incite any party to commit, or assist any unlawful or criminal act such as (by way of example only) copyright infringement or computer misuse;
- contain a statement which you know or believe, or have reasonable grounds for believing, that members of the public to whom the statement is, or is to be, published are likely to understand as a direct or indirect encouragement or other inducement to the commission, preparation or instigation of acts of terrorism;
- contain any of the following:
 - o criminal material (including material relating to terrorism, sexual exploitation of children, including grooming and child sexual abuse material child pornography, racism and xenophobia).
 - material likely to incite violence or hatred against a group of persons or a member of a group of persons based on any of the following grounds: sex, race, colour, ethnic or social origin, genetic features, language, religion or other belief, political opinion, membership of a national minority, property, birth, disability, age or sexual orientation.
 - material which depicts (real, simulated or implied) or promotes nonconsensual sexual acts or coercion (including alcohol related, rape or any situation where force is used to engage someone in sexual activity), sexual activity involving minors, incest, suggestion of underage individuals, drug references, autopsy photos, bestiality, bodily excretions, cannibalism, child sexual exploitation or abuse, chloroform, crushing of live bugs/animals, the exchange of money for sex, gore (blood that has been shed, especially as a result of violence), extreme violence, torture, flogging (severe beating), hypnosis (model hypnosis during sexual activity), kidnapping/abduction, under polygamy dating content, prostitution, necrophilia, rape; or

sacrilegious, self-mutilation, sleeping involving sexual activity; snuff' or 'fantasy snuff', suffocation, blood, scatological, vomit urination related content;

- material which encourages, promotes or provides instructions for: suicide, acts of deliberate self-injury, eating disorders or behaviours associated with an eating disorder, acts of serious violence against a person, a person to ingest, inject, inhale or in any other way selfadminister a physically harmful substance or a substance in such a quantity as to be physically harmful;
- flashing images, a sexually explicit deepfake; or
- o a description of prohibited content or terminology suggesting any prohibited content in the User Content's title or description.

4. Reporting acts or User Content that breach this policy

If you become aware of any User Content or activity that breaches <u>Our Agreement With You</u> (including this policy), please either use the Report buttons on the platform or email us at <u>admin@jigglejiggle.com</u>. You should provide us with as much detail as possible, including a link to or a description of where the User Content is located, the username of the person that you believe is breaching <u>Our Agreement With You</u>, the date and time of the breach, why it breaches <u>Our Agreement With You</u> or this policy and a statement that your report is accurate and true.

5. Law enforcement

We will comply with any law enforcement authorities, including the police and courts that have jurisdiction in connection with any breach of applicable law or Our Agreement With You. If we incur any costs or expenses in doing so, including legal expenses, you agree to reimburse us for those costs and expenses,
